If you are interested in these services, please look below to find a location near you and call the number listed. Some locations may require that an appointment be made. When you go, make sure to take your **driver's license (or photo I.D.), Social Security Cards, Medicaid Card, last year's Tax Return, and all W-2s, 1099s, B, R, and SSA. Regarding the Affordable Care Act, if you have health insurance through the government marketplace, bring your 1095-A.**
